

Governor's Actions on Our Education Supported Bills

October 14 was the deadline for the Governor to take action on the 900+ bills sent to him. Here's a update:

SUPPORT BILLS

CalSTRS Retirement

SB 432 (Cortese): Teachers' Retirement – Would revise the newly updated California State Teachers' Retirement System's auditing rules enacted in 2023, specifically regarding the timeliness and accuracy and how overpaid funds can be recovered. *The Governor signed this bill on September 22nd*. (This was a follow-up bill to CalRTA-Sponsored AB 1667 last year.)

Health Care/Healthy Aging

AB 48 (Aguiar-Curry): Nursing Facility Resident Informed Consent Protection Act of 2023 – Would allow patients in nursing facilities and intermediate care facilities to have the right to be free from psychotherapeutic drugs used for resident discipline, convenience, or chemical restraint, except in an emergency. *The Governor signed this measure on October 13th.*

AB 1241 (Weber): Telehealth – Would require a health care provider under Medi-Cal to maintain protocols for referring patients for in-person care when a standard of care cannot be met by virtual communication. *The Governor signed this measure into law on September 8th.*

AB 1309 (Reyes): Long-Term Health Care Facilities: Admission Contracts – Would require that a resident of a long-term care facility be given facts about their transfer or discharge that include the date, witnesses, and circumstances regarding the reason for that transfer or discharge. *The Governor signed this measure on October 13th.*

AB 1417 (Wood): Elder and Dependent Adult Abuse: Mandated Reporting – Would require mandated reporters to submit a written report within 24 hours to the long-term care ombudsman, law enforcement, or a corresponding state agency if a resident in a long-term care facility was allegedly abused by another resident of the facility with dementia and was diagnosed by a physician and received no bodily injury. *The Governor signed this bill on October 9th.*



SB 694 (Eggman): Medi-Cal: Self-Measured Blood Pressure Devices and Services – Would require self-measured blood pressure devices and services to be covered under Medi-Cal to treat high blood pressure and would include these as intended to be included in covered devices and services upon receipt of any necessary federal approvals. *The Governor vetoed this bill on October 7th, stating the additional costs associated with this bill were not included in the budget.*

WATCH BILL

SB 765 (Portantino): CalSTRS Post-Retirement Earnings Limit – Was recently amended to temporarily increase, for two years, the current post-retirement earnings limitation from 50 percent to 70 percent of the median final compensation for retirees. Will waive the existing sixmonth prohibition from returning to work under specified conditions and includes increased transparency and accountability processes to the existing process for districts to utilize retirees under the post-retirement earnings limit. *The Governor signed this measure on September 13.*

From Kit King: It will be four weeks that I've been at Danville Post Acute Rehab facility Tuesday, November 8th after slipping in the shower in Carmel and fracturing my femur that leads to my recent right leg knee replacement! I'm probably going to be here a few weeks or months more before I can go home!

Doctor told me that if I put too much weight on my right leg what might happen is that the BONES around the hardware may break or fracture! The hardware (rod, plate, screws, nail) won't break. OR my femur won't heal properly! Needless to say, I am being very careful.

I'll know more when I go back to the doctor on the 16th. X-rays should show some healing.
